

PRODUCT WARRANTY – ADP STORE FIXTURES



ADP Store Fixtures' products are engineered for long-term performance and durability. ADP Store Fixtures' promises the original purchaser, at our option, to repair or replace any of the said product or component thereof, subject to normal commercial use that is defective in material or workmanship for the time period offered on the product from date of purchase.

Subject to any express or implied statutory requirements, ADP Store Fixtures offers the following warranty.

ADP Store Fixtures conditionally warrants that its products are free from defects in materials and workmanship for the advertised* period of time applicable to the individual product from the date of invoice (with the exceptions and exclusions specified below).

ADP Store Fixtures, within the advertised* warranty period applicable to the individual product, undertakes to repair or replace with similar or comparable product (at its option) any component found to be faulty in material or workmanship (subject to the provisions below).

This warranty only applies to:

1. The original purchaser and is non-transferable.
2. Faulty materials and/or workmanship in the product.
3. Products sold and used within Australia.

This warranty does not apply to:

1. Normal wear and tear, which have to be expected over the course of ownership.
2. Damage arising from abnormal use.
3. Damage arising from excessive weight loadings.
4. Damage incurred during transit.
5. Where product has been used in outdoor environment.
6. Modifications or attachments that are not approved by ADP Store Fixtures.
7. Products used for rental or hire purposes.
8. Products considered consumables.
9. Customers own materials (COM) incorporated into ADP Store Fixtures products.
10. Any indirect or consequential loss – See 'Limit of liability' clause below.

This warranty is null and void if:

1. The product has been abused, damaged, modified after delivery.
2. The product has been subject to an accident.
3. ADP Store Fixtures is not notified by email within five (5) business days of the fault occurring.
4. The product has been maintained or repaired by someone other than an authorised ADP Store Fixtures representative or approved repair agent.

PRODUCT WARRANTY – ADP STORE FIXTURES



ADP Store Fixtures reserves the right to request that any product subject to a warranty claim be returned to ADP Store Fixtures for inspection before repair or replacement. ADP Store Fixtures may ignore any warranty claim if ADP Store Fixtures is not permitted to inspect the goods on request.

All inspections, repairs or replacements will be carried out at ADP Store Fixtures premises and after inspection, ADP Store Fixtures will repair or replace (at its option) any faulty product or component covered by this warranty free of charge to the purchaser.

The purchaser must pay all costs associated with the return of the product to ADP Store Fixtures premises and the product must be accompanied by proof and date of purchase.

Limit of Liability

The liability of ADP Store Fixtures shall be strictly limited to the abovementioned obligations and ADP Store Fixtures shall not be liable for consequential, incidental or operating loss suffered by Client, to person or property, arising from the manufacturing, distribution, installation or use of the products or services supplied by ADP Store Fixtures. ADP Store Fixtures liability shall be limited to an amount not exceeding the Purchase price for the products in question.
